Overview of Divorce in Montgomery County

Divorce in Maryland may be granted on the basis of either mutual consent or fault-based grounds. In Montgomery County, divorce cases are handled in the Circuit Court located at 50 Maryland Avenue, Rockville.

Once a divorce complaint is filed, the case is assigned to one of several “tracks” that determine how it moves through the court

system. These include uncontested fast-track cases (Track 0), general divorce and support cases (Track 1 or 2), and cases involving contested custody or property (Track 3 or 4).

If custody is an issue, or if there are disputes about assets, the court may order mediation, co-parenting education, or even a full custody evaluation.



Getting Started

To begin a divorce in Montgomery County, one spouse must file a **Complaint for Divorce**. You'll need to include details about living arrangements, children, and finances. After filing, the other party is **served**, and court deadlines begin.

You will also be scheduled for a **scheduling hearing**, which is where the court assigns your case to a track and may order services like mediation or parenting classes. At this stage, having a knowledgeable attorney can help you prepare for what's ahead.

Tip: Even if your divorce seems uncontested, having legal advice ensures your rights are protected.

Child Custody & Visitation

Custody decisions are based on the best interests of the child, not just what parents want. If you and your co-parent disagree, the court may order:



Custody Mediation

A free 3-hour session to help parents reach a parenting agreement.



Co-Parenting Skills Classes

Two sessions covering child development, conflict reduction, and cooperative parenting strategies.



Custody Assessments or Evaluations

Court evaluators (social workers) may conduct home visits, interviews, and provide oral or written reports to the court.

These services aim to minimize conflict and support healthy parent-child relationships.

Family Support Services

Montgomery County offers many free or low-cost resources for families in transition. These include:



Family Law Self-Help Center (Room 1500, South Tower)

Walk-in legal assistance for basic family law questions.



Co-Parenting Book & Resource List

Includes books like Mom's House, Dad's House and Dinosaurs Divorce to support both parents and children.



Mediation Referrals

The Conflict Resolution Center offers free services in some cases.



Evaluations & Psychological Support

Ordered in high-conflict or abuse cases.

Domestic Violence & Protection

If you are experiencing abuse or threats of violence, the court provides immediate help. You can request a protective order through the Circuit Court. Resources available:

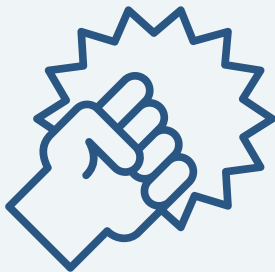
